SAFETY ALERT: CHILDREN USING PRIVATE VANS/PRIVATE BUSES

Dear Parent,

Student safety and well-being remain central to all our decisions and actions. It has been increasingly observed that unregulated private vans/private buses are operating under hazardous conditions. Vehicles designed for less passengers are being used for more children, with school bags blocking emergency exits. Such practices pose serious risks.

While we recognize that many parents rely on private vans/private buses for daily commutes, the safety and well-being of our students must remain our highest priority. Following are our observations-

- **Operation of Private Vehicles:** Lack of speed governors, traffic rule violations and operation without valid permits.
- **Driver Verification:** Absence of proper background verification or police clearance of driver/attendant
- **Overcrowding:** Compromising safety and comfort.
- **Safety Measures:** Lack of GPS, CCTV cameras, first-aid kits, fire extinguishers and lady guards.
- **Child Safety:** No designated lady guard/attendant to supervise children. Children seated near CNG cylinders in boot space, posing extreme fire hazard.
- **Emergency Protocol:** No defined emergency response or accountability mechanism.

Parents are hereby informed that law mandates strict safety norms for school transportation. Parents need to advise their children to promptly report any concerns related to private van transportation—particularly those mentioned above to their teachers at school or to their parents at home. We suggest a **Father/Mother Volunteer** to travel on rotational basis to ensure safety measures are strictly adhered to by private van operators.

In light of the safety concerns outlined above, parents are strongly advised to choose the alternate transport service for their children's commute, as it ensures greater supervision, accountability, and adherence to prescribed safety norms.

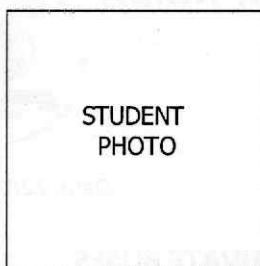
- **School Buses are equipped with CCTV cameras, GPS tracking systems, and undergo regular safety inspections and audits.**
- **Strict compliance with RTO and CBSE transportation safety norms is consistently maintained.**

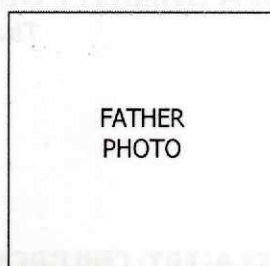

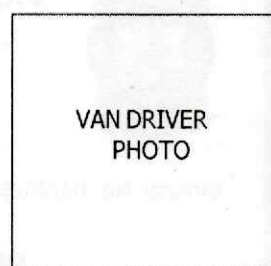

2. That I/we have verified the credentials, driving license, police verification, fitness certificate, insurance, registration and other statutory requirements of the vehicle and driver engaged for the transportation of my/our ward.
3. That I/we acknowledge that the School shall not be responsible or liable for any accident, mishap, delay, misconduct, negligence, dispute or any untoward incident arising during the commute of my/our ward through the private transport facility.
4. That I/we have ensured that the private vehicle engaged complies with all safety norms and transport regulations prescribed by the competent authorities from time to time.
5. That I/we shall immediately inform the school in case of any change in the transport arrangement.
6. The vehicle must not be overcrowded beyond its permitted seating capacity under any circumstances.
7. I/we will ensure that driver is not indulged in any drink & drive habit.
8. I confirm that the private transport provider, complies with all applicable laws and safety regulations.
9. I agree to indemnify and keep indemnified the school, its management, Principal, staff and employees against any claims, liabilities, losses, damages or legal proceedings arising out of or in connection with the use of private transport by my child.
